# **PROCEDURAL MATTERS**

Procedural matters of origin hearing:

Hearing under N1.4

Decission given 19:40 on 15th of October 2022.

Procedural matters of reopened hearing:

Hearing under N1.4

The hearing was reopened under RRS 66.1 without the parties present (the parties was informed of the reopening but did not turn up - RRS 63.3(b)) @11:27 16th of October 2022 after the jury learned that BRA's score in the race F8 was changed to UFD.

Decission changed @11:28 on 16th of October 2022.

#### **FACTS FOUND**

Facts of originI hearing:

- 1. BRA and FIN were sailing on starboard tack and overlapped
- 2. BRA was leeward and FIN windward
- 3. FIN hit an unidentified object on the water that made FIN's kite to go on top of BRA's kite
- 4. There was contact between the kites
- 5. There was no tangle
- 6. When BRA's kite got pressure again her middle line was broken
- 7. FIN took a penalty turn
- 8. BRA did not finish the race because of the broken line

Facts of reopenend hearing:

1. BRA was scored UFD in race F8

# **CONCLUSIONS AND RULES THAT APPLY**

Rules:

Conclusion of orignal hearing:

- 1. FIN to windward failed to keep clear of BRA that was to leeward and broke rule 11
- 2. Despite of taking a penalty, FIN caused damage to BRA in race F8 and broke rule F44.1(b)

Added conclusion:

1. BRA's place in F8 was not made significantly worse since she was already scored UFD. Therefore, the requirements

for redress in RRS 62.1 are not met.
