PROCEDURAL MATTERS

- 1. The panel of the International Jury was composed in accordance with RRS N1.4(b).
- 2. ITA 224701 was represented by Nicolo Utzeri.
- 3. Vincenzo Garau, coach of ITA 224701, attended the hearing as an observer.
- 4. Antonio Rutoli, member of the International Jury, presented evidence as a witness during the hearing.

FACTS FOUND

Facts for validity:

- 1. The results of the ILCA 4 Blue fleet on 4 May were posted at 18:24.
- 2. ITA 224701 saw that he was scored DSQ in race 3, at 18:45.
- Immediately after, ITA 224701 submitted first another request for redress for another race and subsequently this request for redress.
- 4. ITA 224701 submitted the request for redress at 19:02.

Facts Found

- 1. In race 3 of the ILCA 4 Blue fleet, ITA 224701 was starting close to the pin end. A jury rib with two members of the International Jury on board was positioned 10 meters behind the boat.
- 2. Approximately 2 3 seconds before the starting signal, the observers on the jury rib saw ITA 224701 rocking.
- 3. The observers on the jury rib raised and pointed the yellow flag to the boat, made a sound signal by whistling and hailed "ITA 224701".
- 4. The observers on the jury rib hailed ITA 224701 a second time a few seconds later..
- 5. ITA 224701 did not do any penalty and continued sailing.
- 6. This was the first signalled penalty for ITA 224701.
- 7. ITA 224701 was scored DSQ in race 3.
